## DGP PRODUCTS, INC.'S CLOSING ARGUMENTS

DGP Products, Inc. ("DGP") respectfully submits its written closing arguments from the evidentiary hearing held on March 14, 2022, April 25, 2022, April 26, 2022, April 27, 2022, April 28, 2022, April 29, 2022, May 2, 2022, June 14, 2022, June 16, 2022, June 17, 2022, August 29, 2022, August 30, 2022, and October 19, 2022. The debt owed by Faith Elyzabeth Antonio ("Defendant") to DGP is not dischargeable by bankruptcy because the debt is as a result of Defendant's embezzlement of funds from DGP. Moreover, Defendant has willfully and maliciously injured DGP by misappropriating funds and products from DGP as well as disparaging DGP. Rather, the evidence¹ established that while Defendant received social security benefits for an alleged

disability, Defendant received thousands of dollars in compensation over a span of more than four (4) years for her work at DGP.

Additionally, the evidence also established that Defendant took from DGP thousands of dollars more to (a) purchase goods and services for Defendant and her family members; (b) pay for debt Defendant owed to third party vendors; and (c) pay for travel for Defendant and her family all without the permission, knowledge or consent of DGP and/or its owner, Daniel Alan Hilton Geberth ("Geberth"). Last, the evidence has certainly established that Defendant then engaged in an extensive scheme of creating multiple bookkeeping accounts, aliases, and engaged in the forgery of checks to coverup her illegal actions. DGP is entitled to recover \$111,525.89 from Defendant. Defendant should be denied the discharge of the \$111,525.89 she embezzled from DGP.

DGP filed a complaint against Defendant in Pasco County Circuit Case No. 20-CA-0100889-CA-AXWS (the "Theft Claim") seeking damages for the losses as a result of Defendant's theft. DGP was not able to collect damages from Defendant as Defendant filed for bankruptcy before the state court action was fully litigated. DGP then filed a Complaint to Determine Non-Dischargeability of Defendant's bankruptcy claim (the "Adversary Complaint") in the Middle District - Tampa Division [Doc. 1]. After 13 days of trial and many other days to square away the exhibits and address Defendant's baseless and untimely accusations of alleged discovery violations, DGP submits this closing argument in support of its claim against Defendant.

## Brief Procedural History<sup>2</sup>

The parties met on Memorial Day weekend of 2014 just four months after the death of Geberth's wife leaving Geberth's only daughter who was 13 at the time in his sole care. [April 29, 2022 T @ P49/L19 to P50/L14]. In the three months following their fateful meeting Geberth paid thousands of dollars in cosmetic procedures for Defendant. [April 25, 2022 T @ P83/L4 to P85/L8]. In addition, Geberth gave Antonio \$2,000 a month from his personal account. [April 25, 2022 T @ P106/L4 to P108/L2]. It is undisputed that from May to October of 2014, Geberth was impaired due to his opioid addiction caused by poor pain management as a result of several serious surgeries [April 29, 2022 T @ P47/L8 to P48/L14]. It is also undisputed Defendant was keenly aware of Geberth vulnerability [April 25, 2022 T @ P119/L1-7 and P129/L11-17]. A vulnerability Defendant took full advantage of [June 16, 2022 T @ P87/L7-11]. Last, it is undisputed that in October of 2014, Geberth with Defendant's help, sought the help he needed and as a result, since October of 2014 he has been sober. [April 29, 2022 T @ P47/L8-20]

From January to May of 2015, Defendant worked for DGP at a rate of \$2,000 a month [April 29, 2022 T @ P42/L11-23]. Payments were made by Geberth from his personal bank account. From May to August of 2015, the parties separated. [April 25, 2022 T @ P108/L11-18; and P-Ex# 2]. When Geberth realized that he needed help with his business, Geberth reached out to Defendant to make arrangements for Defendant to return to work for DGP. [April 29, 2022 T @ P57/L5-P58/L4 and P-Ex# 2].

This time, the agreed upon rate of pay to Defendant was \$600 a week [April 29, 2022 T @ P60/L14-19; P-Ex# 266 at P-TR03641; and Demonstrative Aid P-Ex# 287]. Payments were made to Defendant from DGP's business account and eventually after Defendant was approved for her social security benefits³, Defendant started to receive cash from DGP as compensation for her work at the company [April 29, 2022 T @ P60/L18-19; April 25, 2022 T @P70/L5-11]. Eventually the parties reconciled and they continued to be romantically involved until November of 2019 [April 25, 2022 T @P123/L15-21 and P-Ex# 2].

It is undisputed that DGP paid Defendant \$600 a week from August 17, 2015 until November 13, 2019 for her work at DGP [April 29, 2022 T P60/L10-19 and P-Ex## 46-97; 266; and 281. See also Exhibit "D" to the Adversary Complaint at Doc. 1]. Defendant's own written words to DGP's owner, Geberth, confirms multiple times two things. First, that she did in fact receive \$600 a week in compensation [P-Ex# 266 at P-TR03641 and P-TR03643]. Second, and more important, Defendant's written words show that Defendant was not satisfied with \$600 a week and believed she was entitled to more as compensation for "running" DGP [P-Ex# 266 at P-TR03641 and P-TR03643].

While the salary paid by DGP to Defendant is not included<sup>4</sup> in the calculation of damages sought from DGP from Defendant [Doc. 720; April 29, 2022 P61/L3-9], Defendant's employment relationship with DGP is important as it provided access to

DGP's books. Defendant's intimate relationship with DGP's owner provided opportunity to successfully embezzle funds from DGP and cover them up for years. Defendant's employment at DGP also provided Defendant multiple opportunities to plan the embezzlement and conceal the transactions so well that it would take the efforts of an expert forensic accountant to decipher the methodology and track the transactions.

It did not help that Defendant consistently misrepresented the facts in this matter. Defendant purposefully and maliciously fabricated discovery disputes and facts with the intent to mislead this Court. Defendant in a repeated effort to deflect the attention from her misconduct<sup>5</sup>, hurled insults and false accusations to DGP and its counsel. Defendant went as far as to accuse DGP's counsel of removing documents from production and committing a fraud upon the Court. An accusation which, as the many others made by Defendant, was found to be false, unfounded, and without merit. Not to mention the fact that Defendant has made a mockery of the justice system and these proceedings by representing on her social media platform inaccurate facts about the proceedings, rulings of this Court and what the evidence presented has proven; that Defendant without a

Counsel for DGP had to track the metadata for each communication, obtain the IP Address Location, which tied the sender to Palm Harbor where the Defendant resided at the time [See P-Ex # 287 admitted as Demonstrative Aid] and even then, when confronted with the truth in plain black and white she then challenged the admission of the document without nothing more than a spew of lies.

doubt embezzled \$111,452.08. Defendant has also consistently manipulated proceedings with the intent of costing DGP's owner great financial loss all to prevent her lies and deceit from seeing the light of day.

## DAMAGES AS A RESULT OF DEFENDANT'S EMBEZZLEMENT

DGP suffered a loss of \$42,183.13 as a result of Defendant's use of DGP funds from the DGP Synovus account. See detailed summary of the Synovus expenses attached hereto as Exhibit " ${\bf B}^{6}$ ".

DGP suffered a loss of \$28,613.62 as a result of Defendant's unauthorized use of DGP's American Express card. See detailed summary of the American Express card expenses attached hereto as Exhibit "C".

DGP suffered a loss of \$36,285.45 as a result of Defendant's misappropriation of checks that Defendant forged in order to (1) pay third party vendors for her benefit; and (2) also pay herself above and beyond the \$600 a week<sup>7</sup> she was already receiving in compensation for her work at DGP. See detailed summary of the checks paid for Defendant's benefit attached hereto as Exhibit "E".

Finally, DGP also suffered a loss of \$4,369.88 as a result of Defendant's misappropriation of checks that she forged in order to obtain a membership for her and her family for Innisbrook. See detailed summary of the checks for Innisbrook attached hereto as Exhibit "G".

The total sum of damages which Defendant stole from DGP is \$111,452.08. The aforementioned damages do not include the losses as a result of Defendant's stealing of DGP products to sell and retain the proceeds from the sale of those products. Likewise, excluded<sup>8</sup> are many other transactions that DGP has conceded to because the "juice is not worth the squeeze" [Doc. 720].

## EFFORTS TO CONCEAL HER EMBEZZLEMENT DEMONSTRATE HER MALICIOUS INTENT

A debt is nondischargeable pursuant to 11 U.S.C. § 523(a)(6) if it is a debt for a willful and malicious injury by the debtor to another entity or its property. *In re McClung*, 335 B.R. 466, 472 (Bankr. M.D. Fla. 2005) (citing *Kawaauhau v. Geiger*, 523 U.S. 57 (1998)). Under Section 523(a)(6), the creditor must establish: (1) willful conduct, (2) malice, and (3) causation. *Id.* Thus, a party objecting to a debtor's discharge must show that the debt arose from an injury that was both willful and malicious. *Id.* A debtor is responsible for a 'willful' injury when he or she commits an intentional act the purpose of which is to cause injury or which is substantially certain to cause injury.' *Id.* at 474.

An injury is "malicious" if it is wrongful and without just cause or excessive even in the absence of personal hatred, spite or ill-will. *In re Saks*, 2022 WL 18273886 (Bankr. M.D. Fla. 2022). Malice may be implied if the nature of the act itself implies a sufficient degree of malice. *In re Ikner*, 883 F. 2d 986 (11th Cir. 1989); see also, *In re Jennings*, 670 F. 3d 1329, 1334 (11th Cir. 2012) (holding that debtor also committed a malicious injury because the injury was wrongful, without just cause, and excessive). In determining the

defendant's subjective intent, the defendant's knowledge or belief may be proven not only by her admissions, but also by circumstantial evidence tending to establish what defendant knew and did when taking the injury producing actions. *In re Saks*, 2022 WL at \*8–9 (Bankr. M.D. Fla. 2022)

The very nature of Defendant's actions implies a malefic intent. Defendant in this matter took affirmative steps to conceal her misappropriation of funds. Once the creditor presents circumstantial evidence of an intent to deceive, a debtor "cannot overcome that inference with an unsupported assertion of honest intent." *Hendry*, 428 B.R. at 78 (internal quotations and citations omitted). "Instead, the court should consider whether the [debtor's] actions appear so inconsistent with [her] self-serving statement of intent that the proof leads th[e] court to disbelieve the debtor." *Id.* (internal quotations and citations omitted). In re Cunningham, 482 B.R. 444, 448 (Bankr. N.D. Ala. 2012)

<u>First</u>, Defendant's use of multiple email addresses allowed her the ability to create and sign in to various Intuit accounts and third party vendors providing the perfect cover<sup>9</sup> for her unauthorized transactions [P-Ex# 265 at 35].

Second, the creation of multiple Intuit accounts permitted Defendant to conduct transactions solely for her benefit without the knowledge and/or supervision of DGP. Defendant herself states that Geberth was unable to tend to the day-to-day business matters because he was often under the influence of drugs [April 25, 2022 T @ P119/L1-7 and P129/L11-17]. As Defendant was aware, each Intuit account opened allowed

Defendant another opportunity to learn more about the program features and consequently, provided her additional skills to cover up her unauthorized use of DGP funds. [Doc. 450<sup>11</sup> P 193 of 2155].

Defendant created a total of 7 Intuit/QuickBooks accounts [P-Ex# 265 at 97]. [August 29, 2022 T@ P91/L9-22]. It was through the use of the various Intuit accounts that Defendant was able to pay her personal credit cards by issuing payments and checks to the vendors and then disguising<sup>10</sup> them by renaming and/or relabeling the vendor to another commonly known DGP vendor. It also allowed Defendant to create, print and issue checks offsite with a forged signature.

Third, Defendant created a fake Intuit profile as an accountant user, i.e., Marca Schulz [Doc. 450<sup>11</sup> at P1211 of 2155]. Under the fake profile of Marca Schulz, designated as an accountant user in QuickBooks (Intuit), Defendant had additional privileges that allowed Defendant to undo entire reconciliations<sup>12</sup>, reclassify transactions and write off invoices. Privileges that no other classification of user in Intuit would have.

None of these schemes would have been necessary had DGP and/or Geberth truly agreed to provide these goods and services to Defendant as Defendant now conveniently

alleges. Moreover, only Defendant and her family benefitted from the transactions completed using Defendant's cover up schemes.

# Defendant's Scheme with Multiple Methods of Concealment Helped Defendant Hide her Misappropriation of Goods and Funds for Years

Defendant used multiple schemes to cover up her unauthorized behavior and remain undetected which allowed Defendant to continue to steal from DGP for an astonishing length time, to wit: four years. Had Geberth and Defendant not ended their romantic relationship forcing Geberth to reconcile DGP's books, there is no telling how much longer Defendant would have continued to pilfer DGP's coffers.

During the four years of the ongoing embezzlement, Defendant utilized and/or was associated with a total of 11 emails [P-Ex# 265 at 35]. Some emails were used to create new online Intuit accounts. Other emails were used to set up her multiple PayPal and Amazon accounts. It took extraordinary effort to corroborate the email addresses used by Defendant. At every turn Defendant denied ownership of email addresses and further concocted stories in an attempt to convince the Court that Geberth somehow had accessed her email account and created fake Intuit accounts to frame her.

Such rhetoric is ridiculous and presented to this Court by Defendant without a scintilla of evidence. There is nothing to be gained by Geberth in creating multiple Intuit accounts. On the contrary, the creation of multiple Intuit accounts was part of Defendant's calculated scheme to create the perfect smoke and mirrors to detract attention from her embezzlement. Furthermore, Defendant's actions have created a spiderweb of misfeasance that has hindered DGP's ability to assess the true damages

suffered and caused DGP to suffer even more damages in attorney's fees and costs to untangle. It is without a doubt that such confusion and chaos benefits no one more than Defendant. It is Defendant who has been able to receive compensation above and beyond the amounts agreed to by DGP for her work at the company. That is because Defendant received her agreed upon salary from DGP PLUS more than \$111,525.89 in good and services for her benefit. Defendant has been enriched on DGP's dime over the years, all while defrauding the federal government and collecting social security benefits for her alleged inability to work<sup>13</sup>.

For example, Intuit Account ending in 0709 was created by using Defendant's email account of <a href="mailto:faithantonio40@gmail.com">faithantonio40@gmail.com</a> under the alias of Elisabeth Martin [April 26, 2022 T @P31/L5-8; August 29, 2022 T @P94/L3-P95/L4; and Doc. 450<sup>11</sup> at P28 of 2155]. It is undisputed that once an email is linked to the creation of an Intuit account, Intuit sends a confirmation email to the email that was used to create the account. It is also undisputed that <a href="mailto:faithantonio40@gmail.com">faithantonio40@gmail.com</a> was Defendant's email, Defendant admitted herself to the use of that email [June 17, 2022 T @ P40/L2-11]. Thus, only Defendant would have received the authenticating email to open the online Intuit account [August 29, 2022 T @P94/L22-24].

Certainly, at the very least Defendant has demonstrated that she has the capacity of working at a job doing administrative tasks.

Defendant's sole access to alternate Intuit accounts also afforded her an opportunity to print checks off site. An opportunity Defendant took full advantage of. Defendant printed several checks to pay for goods and services for the benefit of herself or her family members. The checks created from the alternate Intuit accounts had signatures that appear be identical duplicated signatures. The duplication of signatures is readily observable to the naked eye by simply interposing one check on top of the other a lay person can observe that the signature is placed on the same exact location on each check with the same spacing between the line and signature [P-Ex# 265 at P 102-111<sup>14</sup> (Exhibit 19 to the Expert Report) and Doc. 1048-1<sup>15</sup> at P 72-75] An impossible feat for any person signing any document as there is always a natural variation in everyone's writing.

## How "Marca Schulz" Benefited Defendant

Defendant created Marca Schulz's accountant profile on August 16, 2018 at 06:27:45 PM PDT by using her email address of <a href="mailto:faemny33@gmail.com">faemny33@gmail.com</a> [Doc. 45011 at P1213 of 2155]. The email address of <a href="mailto:faemny33@gmail.com">faemny33@gmail.com</a> is an email address that belongs to Defendant. Defendant denies that this is one of her many email addresses because to admit as much would be akin to admitting her extensive efforts to cover up her embezzlement of funds from DGP. Defendant's repeated misrepresentations during the litigation of this case is clear evidence that Defendant is not credible. Defendant cannot hide from the fact that <a href="mailto:faemny33@gmail.com">faemny33@gmail.com</a> was a verified address used and linked to her personal PayPal account [P-Ex#190 at P-TR01399; and P-Ex# 265 at P37].

Moreover, the selection of the name Marca Schulz was also deliberate. There are no accountants registered in the state of Florida under the name of Marca Schulz [August 29, 2022 T @P97/L2-8; June 17, 2022 T @P50/L23-P51/L5; and P-Ex# 265 at P39] Defendant's favorite DJ is Markus Schulz [April 26, 2022 P122/L7-16 and P-Ex# 285]. Under the alias of Marca Schulz, Defendant edited many transactions to conceal that she had issued many checks to vendors for her benefit without the consent of DGP or its owner Geberth. Marca Schulz edited many transactions to the benefit of Defendant and to detriment of DGP. If Defendant was in a relationship where Defendant believed she had free reign, Defendant would have had no motivation to miscode any transactions.

It is important to note the following chronology:

- On August 16, 2018 at 01:42:34 PN PDT the Online Banking Automatically is
   Updated and Synovus Bank transactions are downloaded into the QuickBooks
   account [Doc. 450<sup>11</sup> at P1214];
- On August 16, 2018 at 06:27:45 PM PDT confronted with the realization that the QuickBooks account has now reconciled all checks created on the alternate QuickBooks online account that have now been cashed at Synovus into the main desktop QuickBooks account, Defendant signs in using her email of <a href="mailto:faemny33@gmail.com">faemny33@gmail.com</a> to create an accountant user that can erase the transactions downloaded by the now reconciled bank account in one sweep [Doc. 45011 at P. 1213 of 2155]. Defendant knew that Geberth usually met with the true accountant for DGP, Cohen & Grieb, in the fall and that Geberth would be discussing any uncategorized expenses with the accountant [May 2, 2022 T @ P15/L15-20].

- On August 16, 2018 at 08:14:01 PM PDT Defendant then edits the user to include
   Marca Schulz as a certified public accountant [Doc. 450<sup>11</sup> at P 1211 of 2155].
- On August 16, 2018 at 08:14:46 PM PDT Defendant logs in as Marca Schulz for the very first time [Doc. 450<sup>11</sup> at P 1211 of 2155].
- On August 16, 2018 at 08:19:34 PM PDT the very first task Defendant completes under her alias Marca Schulz is to undo the reconciliation of the Synovus Bank statement with the QuickBooks account [Doc. 450<sup>11</sup> at P 1211 of 2155].
- On August 16, 2018, Defendant proceeds to edit all the transactions in an effort to conceal substantial funds Defendant has embezzled and more important hide the forged checks she has issued and have been cashed for her benefit [Doc. 450<sup>11</sup> at P.
   1203 to 1211]. For example:
  - o Check 1912 for \$988 payable to Tech ID for Defendant's son summer camp but edited to falsely reflect that the check payable to Welltek [Doc. 450<sup>11</sup> at P1204 of 2155 and Doc. 1048-1<sup>15</sup> at P65 of 99];
  - o Check 1912 for \$988 payable to Tech ID for Defendant's son summer camp but edited to falsely reflect that the check payable to Welltek [Doc. 450<sup>11</sup> at P1204 of 2155 and Doc. 1048-1<sup>15</sup> at P65 of 99];
  - o Check 1929 for \$800 payable to Defendant but edited to falsely reflect that the check was payable to W [Doc. 450<sup>11</sup> at P1204 of 2155 and Doc. 1048-1<sup>15</sup> at P66 of 99];
  - o Check 1933 for \$800 payable to Defendant but no vendor entered on audit trail [Doc. 450<sup>11</sup> at P1206 of 2155 and Doc. 1048-1<sup>15</sup> at P67 of 99];

- o Check 1939 for \$800 payable to Defendant no vendor entered on audit trail [Doc. 450<sup>11</sup> at P1207 of 2155 and Doc. 1048-1<sup>15</sup> at P67 of 99];
- o Check 1940 for \$800 payable to Defendant but edited to falsely reflect that the check was payable to W [Doc. 450<sup>11</sup> at P1207 of 2155 and Doc. 1048-1<sup>15</sup> at P68 of 99];
- o Check 1941 for \$800 payable to Defendant but edited to falsely reflect that the check was payable to W [Doc. 450<sup>11</sup> at P1207 of 2155 and Doc. 1048-1<sup>15</sup> at P68 of 99];
- o Check 1945 for \$800 payable to Defendant but edited to falsely reflect that the check was payable to W [Doc. 450<sup>11</sup> at P1208 of 2155 and Doc. 1048-1<sup>15</sup> at P68 of 99];
- Check 1925 for \$1,100 payable to Merrick Bank but edited to falsely reflect that the check was payable to Welltek [Doc. 450<sup>11</sup> at P1204 of 2155 and Doc. 1048-1<sup>15</sup> at P66 of 99];
- o Check 1909 for \$600 payable to Innisbrook which Defendant told Geberth it was a fee for advertising when in fact it was a family membership for Defendant's family [April 29, 2022 T @P79/L20-P80/L4 Doc. 450<sup>11</sup> at P1206 of 2155; Doc. 1048-1<sup>15</sup> at P64 of 99; and P-Ex# 174]; and
- o Deleted several Amazon Payments [Doc. 450<sup>11</sup> P. 1964 of 2155].

To name a few.

 On August 31, 2018 at 10:38:41 AM PDT Defendant then deleted the Marca Schulz profile [Doc. 450<sup>11</sup> at P 1197 of 2155]. By then Marca Schulz has served her purpose and served it well.

It is important to note that from August 16, 2018 to August 31, 2018, Marca Schulz performed no other tasks in QuickBooks. More importantly, the sum total of Marca Schulz edited transactions provided a cover up of \$17,166.99\(^{16}\) worth of transactions, ALL for Defendant's sole benefit [Doc. 450\(^{11}\)] at P1203 to 1211].

The creation of Marca Schulz as an Accountant in DGP's online Intuit profile benefited no one but Defendant. The audit logs reflect the dates on which these transactions took place as they unfolded in real time. If this profile was created by Geberth, or anyone else at DGP, to "frame Defendant" as Defendant repeatedly claims, they would have been created post break up (after November 2019) when Geberth and/or DGP learned of the embezzlement and not on August 16, 2018 when in fact Defendant added Marca Shulz as a user [Doc. 450<sup>11</sup> P 1211 and 1213 of 2155]. The user Marca Schulz was deleted as a user just 15 days later (on August 31, 2018) after Defendant had succeeded in hiding her tracks [Doc. 450<sup>11</sup> at P 1197 of 2155].

# Defendant's Affirmative Defenses are Not Applicable

First Affirmative Defense - Consent

Of the many affirmative defenses asserted by Defendant, only a few remain.

Defendant's First Affirmative Defense claiming that Defendant had the consent of DGP's

owner, Geberth, to raid DGP's till at the tune of \$111,525.89 for her benefit. There is no evidence that Geberth or anyone else at or on behalf of DGP consented to Defendant's use of DGP funds to pay for personal expenses for Defendant and her family. Despite Defendant's repeated self-serving statements that Geberth consented to all the funds she took from DGP, Defendant has not produced a single email, text message, call log, love letter, note, online or social media platform exchange, not even a post it note, wherein Geberth expresses his consent, permission and/or approval of any of the purchases made by Defendant using DGP funds.

Regardless, consent is not applicable in cases of embezzlement. A Chapter 7 debtor is generally entitled to a discharge of all debts that arose prior to the filing of the bankruptcy petition." *In re Mitchell*, 633 F. 3d 1319, 1326 (11th Cir. 2011) (citing 11 U.S.C. § 727(b)). "However, this 'fresh start' policy is only available to the 'honest but unfortunate debtor.' " *Id.* (quoting, *In re Fretz*, 244 F. 3d 1323, 1326 (11th Cir. 2001). "To ensure that <u>only the honest</u> but unfortunate debtors receive the benefit of discharge, Congress enacted several exceptions to § 727(b)'s general rule of discharge." *Id.* Emphasis added. Section 523 contains a list of such exceptions that will bar a discharge; however, "section 523 must be narrowly construed, and the creditor has the burden of proving by a preponderance of the evidence that an exception to discharge applies." *In re Cunningham*, 482 B.R. 444, 447 (Bankr. N.D. Ala. 2012) (citing *In re Bullock*, 670 F. 3d 1160, 1164 (11th Cir. 2012).

Embezzlement has been long defined for dischargeability purposes as "the fraudulent appropriation of property by a person to whom such property has been

entrusted, or into whose hands it has lawfully come." *Moore v. United States*, 160 U.S. 268 (1895). Therefore, **embezzlement differs from larceny** only in that the initial taking of the property was lawful, or <u>with the owner's consent</u>." *In re Cunningham*, 482 B.R. 448. Emphasis added.

Even if consent was an element to consider in embezzlement claims, it is clear that DGP and/or Geberth did not consent to Defendant's unlimited use of DGP's assets, income and products to benefit Defendant, Defendant's parents, Defendant's sister and/or Defendant's children. While it is true that DGP provided Defendant an American Express, that American Express was to be used for business purchases only [May 2, 2022 T @P18/L6-23; June 16, 2022 T @ P87/L2-11]. Likewise, Defendant's use of the funds available in DGP's Synovus account was limited to her salary [May 2, 2022 T @P51/L22-P52/L4].

Had DGP authorized the use of the bank funds held in the Synovus bank account for Defendant's personal expenses, Geberth would have signed all of the checks authorizing payment to third party vendors for Defendants benefit. Instead, Defendant forged Geberth's signature on the checks and then had to create various alternative Intuit accounts to conceal the transactions which in turn required an alter ego accountant to manipulate the program and conceal the transactions.

It did not help that Geberth was trusting of Defendant and was mostly focused on the designing and manufacturing side of the business instead of the administration<sup>17</sup>

 $<sup>^{17}</sup>$  Defendant herself recognized that Geberth spent most of his time building and designing shifters while she was sitting "in the office alone most of the day" [P-Ex# 266 at TR03641].

[June 16, 2022 T @ P87/L7-11]. An error that cost Geberth thousands of dollars and certainly taught him a lesson that will not soon be forgotten.

#### SEVENTH AFFIRMATIVE DEFENSE - NO FIDUCIARY DUTY

Defendant asserts as her Seventh Affirmative Defense that DGP has failed to show that there is a work relationship that created a fiduciary duty. First, the evidence clearly supports that Defendant worked for DGP. Regardless, this affirmative defense is not applicable. Unlike defalcation while acting in a fiduciary capacity, 11 U.S.C. Section 523(a)(4) does not require the exisdeptence of a fiduciary relationship in order to establish that a debt created by an act of embezzlement is nondischargeable. *In re Kelley*, 84 B.R. 225, 231 (Bankr. M.D. Fla. 1988). *Id.* See also, *In re Magpusao*, 265 B.R. 492, 497 (Bankr. M.D. Fla. 2001).

TWELFTH [SIC] DEFENSE - FAILURE TO COMPLY WITH CONDITION PRECEDENT

Defendant's Twelfth Affirmative Defense for DGP's alleged failure to comply with the condition precedent of notice is a red herring and inapplicable. DGP provided to Defendant on February 5, 2020 a Civil Theft Notice and Demand. That same Civil Theft Notice and Demand was attached to the complaint filed on April 2, 2020 and served upon Defendant on April 27, 2020 in the Theft Claim.

DGP also issued a second demand letter to Defendant's then counsel, Brendan Riley on August 13, 2020 at 5:12 p.m.<sup>18</sup> which was attached as Exhibit "H" in the Adversary Claim.

<sup>&</sup>lt;sup>18</sup> On <u>August 7, 2020</u> mailed to Defendant a demand letter and on August 13, 2020 DGP mailed an amended demand letter both via certified mail, return receipt requested. As expected, Defendant refused receipt of the letters to now claim that she did not receive the letters.

Even if the demand letter had not been provided, there is certainly no prejudice and should not be grounds to disregard DGP's complaint. The purpose of providing a demand letter is to allow a defendant an opportunity to comply with the demand. Defendant had no intention in doing so. Therefore, whether or not the letter was received by Defendant is of no consequence. See *Christopher Advert. Grp., Inc. v. R & B Holding Co.,* 883 So. 2d 867 (Fla. 3d DCA 2004) (holding that premature filing of civil theft claim on same day it delivered demand letter to former client was harmless where the defendant had no intention of complying with the demand).

Defendant has asserted that a party's right to sue must be measured by the facts as they exist when the suit was instituted and relies upon a case from 1929 is support of that contention. Should Defendant believe that the demand letter would somehow provide the "measure of damages" [Doc. 75], a number of federal courts, including this Court, have held that a settlement offer (demand letter) may be relevant but not determinative of the amount in controversy. *Zabic v. Cellco P'ship*, 2015 WL 5921851, at \*2 (M.D. Fla. 2015)

#### CONCLUSION

The debt Defendant owes to DGP is a clear product of theft and embezzlement. Defendant's actions that lead to the embezzlement of funds from DGP is precisely the conduct that § 523 was created to address. Defendant's dishonesty precludes the dischargeability of the debt she owes to DGP in this matter. If nothing more, Defendant's actions during trial shows Defendant's true deceptive character. Defendant's false and unfounded accusations hurdled against DGP and its lawyers, created undue delays and

extraordinary attorneys' fees and costs to defend. Defendant's web of lies hindered DGP's ability to gather additional evidence to show the true totality of the embezzlement. In many instances, DGP conceded many transactions because the "juice was not worth the squeeze." Defendant conceded nothing and continued to deliberately hinder the resolution of this matter to cause Geberth to incur fees as if the matters herein were nothing more than a game.

ACCORDINGLY, Defendant's request to discharge this debt through her bankruptcy claim must be **DENIED**.
